RETURN TO WORK PROGRAM

One of the best cost containment measures in workers' compensation is an effective early return to work program.

San Diego and Imperial County Schools JPA takes pride in our program that returns your employees to work as early as possible to meaningful and productive work.

Our partnership with a consulting team of licensed nurses, occupational therapists, and other health care specialists launched a program specifically designed for the unique needs of the education sector.

HEALTH CARE NETWORKS

San Diego and Imperial County Schools JPA is dedicated to partnering with high quality, cost-effective health care networks.

Our health care networks manage workers' care throughout their course of treatment and help reduce program costs through discounted fees.

We are pleased to offer our JPA members the following contracted services.

Medical Provider Network (MPN) –Our members share the benefit of services and provider discounts from the San Diego and Imperial County Schools JPA's state-approved MPN, a Preferred Provider Organization (PPO).

California reform mandates injured employees must utilize the services of MPN contracted medical providers (unless the employee has pre-designated a treating physician). Our annual assessment ensures that network performance continues to meet the high standards our members deserve.

Durable Medical Supply Provider Network – Fees for durable medical supplies are a potentially costly expense for workers' compensation programs.

As a JPA member, you gain significant savings through discounted fees for all your durable medical goods, devices and supplies from our contracted durable medical supply provider network.

Diagnostic Radiology/Neurodiagnostic Testing Provider

Network – Advances in medical technology, such as magnetic resonance imaging (MRI), computed tomography (CT) or electromyography (EMG), come at a high price.

With our pooled purchasing power, San Diego and Imperial County Schools JPA successfully negotiated a contract with a national provider network to deliver diagnostic radiology and neurodiagnostic testing for our members at discounted fees, generating substantial savings.

Pharmacy Benefit Management Program – Pharmacy benefit management is more than the dispensing of high-quality, cost-effective medication.

Our JPA's pharmacy benefits manager is a leader in trend and utilization management with a large network of participating pharmacies.

JPA members benefit from a partner focused on improving patient outcomes and reducing wasteful expenses that occur with inefficient management of prescribed medications.

COST MANAGEMENT

San Diego and Imperial County Schools JPA values our education colleagues. Where we can ease the burden of administration, we are happy to do so.

Pre-placement Physicals – Our JPA pays for pre-placement physicals. There is no additional charge for this service as the fee is part of our workers' compensation bundled rate. Our payment frees you from any concerns about establishing a line item on your budget or making payments for pre-placement physicals from your general fund.

Department of Transportation (DOT) Testing – We also pay for required random drug testing for drivers working for member schools with no additional charge to the workers' compensation rate.

Focusing on Health

Managing health care is a collaborative effort of the individual and the health care provider. Even the healthiest of employees have accidents or develop illnesses. Engaging employees in their health care helps them gain their optimal health.

Case studies reveal that a focus on improving health in the workplace dramatically reduces the incidence of workers' compensation claims. Our JPA offers additional programs for improving the physical, mental, and social well-being of our members' employees.

IMPROVING CASH FLOW

Our JPA has a history of helping our members improve cash flow during fiscally challenging times.

Annually, the JPA Executive Committee and Board review the appropriateness of delaying collection of workers' compensation and property and liability contributions from July 1 to October 1.

The decision to do so is a welcomed reprieve from incidences of state deferrals.

PROTECTING YOUR INTERESTS

San Diego and Imperial County Schools JPA workers' compensations and property and liability programs are self-insured with reinsurance to protect against large losses.

To better manage costs and control claims for all of our programs, we steadily increased self-insured retention amounts.

Our JPA members have control over individual funds. Annually, after equity is actuarially calculated, we return excess funds to our members.

Our programs are funded at a 90 percent confidence level.

Members helping members is what San Diego and Imperial County Schools JPA is all about.
